On behalf of FEIF and ÖIV, we would like to invite you to Austria for the fifth FEIF Young Leaders' seminar. FEIF Youth work is offering a series of annual seminars, focussing on the age group 18-26 when great changes take place in the lives of young people. Due to the current pandemic, the focus of the seminar is on reaching and motivating children and young people in order to teach them cohesion. Since in this context social media are widely used, it is our concern to teach young adults how to use them correctly and fairly.

**TEASER EVENT** There will be an **online seminar on 21st of November** about leadership skills, representing oneself through current creation tools in the best way possible, and how to use this knowledge in the equestrian world, or more specifically to encourage young adults in your local sport clubs.

This seminar is the preparation for the face-to-face event 1-3 April 2022, and it is expected that you participate both online in November, and in Vienna in April.

**Guest speakers for seminar** are Sigrid Brandstetter and Daniel Brandel. They are going to host workshops about online data privacy and leadership topics among digital media.

The April event in Vienna is part-theoretical and part-practical. Places are limited, and the maximum number of participants is 30.

**Registration** is only possible via your national association (it is not possible to register without confirmation from the national youth leader). Each FEIF member association can apply for 2 places but may add further names on a waiting list.

Deadline face-to-face seminar: **25<sup>th</sup> February 2022**

Participants are only registered after full payment has been received by FEIF.

Please note that in April, the applicable COVID-19 measures need to be followed in order to participate in the event.

## **Practical information**

**Venue:** JUFA Hotel Wien-City, Mautner Markhof-Gasse 50, A-1110 Wien

**Programme:** The seminar will start Fri, 1<sup>st</sup> April 2022, 16:30 at JUFA Hotel Wien City and ends Sun 3<sup>rd</sup> April 2022, right after lunch.

**Travel:** From Vienna International Airport you can take the train S7 to Wien Geiselbergstraße, which is 1km away from the venue. From the city of Vienna, you can take the U3 to Enkplatz and walk 500m to get to the location.

**Age group:** 18 – 26 years. (Eligible are young people who are no younger than 18, and no older than 26 at the time of the seminar)

**Costs:** Cost for the online seminar is €35.- For the April event the fee is €220,- minus €15.- deposit from the November event, and covers full board and accommodation (alcoholic and non-alcoholic beverages are not included). The cost for anyone not able to attend the online seminar in November is €220.-
